Wisconsin Administrative Code PI-8.01(2)(h)1

(h) *Library media services.* Each school district board shall:

- 1. Have on file a written, long-range plan for library services development which has been formulated by teachers, library and audiovisual personnel and administrators, and approved by the school district board.
- 2. Designate a licensed library media person to direct and coordinate the district's library media program.
- **3.** Provide library facilities within the school building and make available to all pupils a current, balanced collection of books, basic reference materials, texts, periodicals, and audiovisual materials which depicts in an accurate and unbiased way the cultural diversity and pluralistic nature of American society.
- **4.** Provide library media services to all pupils as follows: to pupils in grades kindergarten through 6, library media services which are performed by or under the direction of licensed library and audiovisual personnel; and to pupils in grades 7 through 12, library media services which are performed by licensed library and audiovisual personnel.

Leads professional learning to cultivate broader understanding of the skills that comprise success in a digital age (e.g., critical thinking, information literacy, digital citizenship, technology).


Current & Prior Practices

- There is a District Library webpage for access to LMC activities and materials.
- Professional development is available through meetings at CESA 12, SLATE, WEMTA, Life Skills, and technology conferences.
- The LMC has sufficient space and organization to handle various student activities including individualized study and class work.
- The LMS gathers information from teachers and students on types of materials to support learning and lifelong reading.

- Increased opportunity for interaction with teaching staff supporting classroom and library skills, team teaching, all of which have been limited due to the pandemic.
- Support teachers with remote/blended learning.
- Lessons in the district include Internet safety.
- Provide lessons and library skills supporting student learning.
- More time devoted to LMC responsibilities, individual interactions with students and staff.

Robust Infrastructure

Ensures Equitable Digital Access

Provides and advocates for equitable access to collection tools using digital resources, programming, and services in support of the school district's strategic vision.

Current & Prior Practices

- The district is 1:1 at grade levels 3 through 12. Technology is readily available.
- Provide 24/7 access to online databases and resources on our library webpage.
- Wireless and Internet access are good throughout our building.
- Equipment is updated as needed.
- Beyond the pandemic, there will be scheduled classes for the elementary in the LMC.
- There is a Reading Buddy system coordinated between Middle School and Elementary classes with the older students reading and interacting with the younger students.

Possible Areas for Growth

- Concern about the lack of open times in the LMC due to the pandemic.
- More opportunity to work with classes to ensure that materials are available.
- More time to focus on LMC requirements like working with individual students, or directing a library class.

Current & Prior Practices

- Maintain accurate records of spending
- Manage CSF to purchase resources across a variety of platforms including digital and print.

- Ongoing updating of our collections.
- Provide online databases regularly to help address curriculum needs.
- Working with teachers and students to give them a voice in the selection of new materials
- Make the most efficient use of our Common School Funds (CSF).
- Suggest items to staff that would provide support for their curriculum.
- Annual book fairs through the LMC.
- Involvement with CESA 12 and DPI personnel.
- Regularly run reports on digital collections, both books and databases to monitor usage.

- Promote resources provided by <u>Badgerlink</u> and <u>WISELearn</u>.
- We are unable to provide more MakerSpace opportunities due to a lack of storage and working space for those types of materials in the LMC. Consideration is being given to be able to accommodate this concept.
- Grant writing to address various needs.
- Provide the focus on having a strong central LMC rather than smaller classroom libraries.
- Legislative safeguarding of the CSF monies so that it doesn't get absorbed in the general fund since this is the primary source of local LMC funding.

- Continued collaboration and communication with state and local agencies such as CESA and DPI
- Communicate with the Public Library about resources and programming.

- Students in grades K-5 have structured lessons with the LMC paraprofessional regarding Digital Citizenship/Safety.
- Chromebooks prevent viruses/malware.
- Students have secure logins for online digital programs.

Students should be continuously reminded of digital citizenship skills they have learned in past lessons/grades to make it a natural part of the research process.	Make the digital citizenship topics/skills a part of every lesson (always reviewing) whenever students engage in creating and/or researching. This should be a priority for every teacher in every curriculum area when online resources are being used.



Collaborative Leadership

Leads Beyond the Library

Participates in setting the school district's vision and strategic plan for digital learning and fosters a culture of collaboration and innovation to empower teachers and learners.

Current & Prior Practices

- Serve on various local committees such as District Strategic Planning.
- CESA 12 Library Media Network Members.
- Time to meet with teachers and/or administrators if requested.
- Common Sense media scope and sequence strengthening digital literacy.
- Library curriculum focuses on ITL standards such as Digital citizenship, Research Skills, Keyboarding, Badgerlink, accessing databases, copyright laws, avoiding plagiarism, search strategies, identifying fake news versus legitimate sources, evaluating websites, etc.
- Supporting staff with their curriculum needs.
- Teaching students and teachers how to access LMC materials via Destiny.

- Strengthening and building LMC curriculum and being fully aligned with Information and Technology Literacy Standards (ITLS).
- More time and/or personnel to focus on LMC needs, training, and teaching.
- Time at the beginning and end of the school year to pull and prepare LMC activities.

Provide time for LMS to work "with" the classroom teacher to integrate ITL standards within the curriculum.	Time should be designated (summer curriculum building, Inservice days, PLC times, prep time, after school hours, etc.) for this to happen.
Staff should feel comfortable asking for help from the LMS and request the services of the LMS to help with the digital part of their lessons.	PROMOTE. PROMOTE. Many teachers don't know what they don't know only because they have never had a LMS to work with.

Use of Space and Time

Designs Collaborative Spaces

Provides flexible spaces that promote inquiry, creativity, collaboration, and community.

Current & Prior Practices

- Libraries are designed to be used for more than designated library times.
- Beyond the pandemic times, there are students and/or classes in the LMC throughout the day.
- Activities have been created to incorporate creativity and critical thinking.
- Spaces are designed to meet the needs of diverse learners. (quiet spaces, collaborative spaces)
- Rotate displays to promote curiosity and highlight new topics.
- Flexible seating in the library spaces.
- LMC personnel are dedicated and efficient.
- The space is accessible to the school community

- Increase space options for collaboration, quiet reading and creativity. Planning for more differentiation in spaces to ensure there are spaces for working together in small groups, some additional display spaces, and more flexible furniture availability.
- More opportunity to work with teachers. Staff utilization could be improved.
- Continue to build collections and resources for center and maker activities.
- Library personnel are responsible for supervision as well as library duties and working with staff and students.

• Review the need for a security system.

MS/HS: Scheduled ELA classes, weekly or biweekly for books check out/browsing; seeing what's new in the library, or mini lessons from the LMS on topics timely to current lessons. Anything to get our students "IN" and using the library and its resources.	Possible directive from administration to require ELA teachers to find a day of the week and a time (that doesn't overlap with elementary scheduled library times.) This would get students in the library, and possibly peak interest in resources that are there for them.



Curriculum, Instruction, and Assessment

Curates Digital Resources

Leads in the selection, integration, organization, and sharing of digital resources and tools to support transformational teaching and learning and develops the digital curation skills of others.

Builds Instructional Partnerships

Partners with educators to design and implement evidence-based curricula and assessments that integrate elements of deeper learning, critical thinking, information literacy, digital citizenship, creativity, innovation, and the active use of technology.

Empowers Students as Creators

Encourages and facilitates students to become increasingly self-directed as they create digital products of their learning that engage them in critical thinking, collaboration, and authentic real-world problem solving.

Current & Prior Practices

- Pull curricular materials for classroom teachers.
- Teach digital citizenship skills (including copyright, citing sources)

Possible Areas for Growth

- Participate in meetings to help inform instruction and provide support for students and teachers.
- Integrate information and technology literacy skills into the library.
- More time for a certified Library Media Specialist. We are presently contracted with CESA 12 for 16 days of a certified LMS time. We have contracted for 40 days for the upcoming year.
- Curate collections in Destiny Discover to support curricular units.
- Increasing staff awareness of LMC opportunities through professional development. Staff would benefit from training on LMC benefits as an extension of the classroom.
- Work with Instructional and Literacy Standards (ITL).
- Team teach lessons incorporating research skills into the curriculum

Curates Digital Resources

Current & Prior Practices

- Subscriptions to a variety of databases for all levels.
- Update library web page with new information and resources.
- Get input from teachers about resources needed to support curriculum.

- Collect data annually about circulation and digital resources.
- Time to truly promote new materials.

Empowers Students as Creators

Current Practices

- Assessment is observation and growth. Work with students to effectively use print and nonprint materials.
- Ongoing work in progress is ethical use of nonprint materials.
- Provide age appropriate digital and print resources for all students.
- Provide a wide variety of reading materials for a wide range of reading levels.

- Encourage students to use maker spaces to create products for their projects in class.
- Opportunities for organizing and integrating MakerSpaces.
- Teaching Digital Citizenship Safety to students.
